In furtherance, it is brought to the notice of all trade & industry, all the tax payers of Central Excise, Customs duties & Service Tax, falling under Central Excise, Customs & Service Tax, Vadodara-II Commissionerate that Vadodara-II Commissionerate is now also starting a Short Messaging Service (SMS) from 10th October 2016 in the adjudication section to disseminate information related to various aspects of adjudication, in addition to the postal letters/e-mail.

- (a) Date of Personal Hearing: On according the date for personal hearing by the Principal Commissioner/Commissioner/Additional Commissioner/Joint Commissioner/Assistant /Deputy Commissioner (Adjudication), the following message shall be sent:
- " With reference to your show cause notice dt.XX.XX.2016, Personal Hearing has been fixed on XX.XX.2016 at XX.XX Hrs.
- **(b)** Request for postponement of personal hearing: On receipt of a request for change in date of personal hearing from an appellant, an acknowledgment message shall be sent.

(c) Issuance of final Order-in-Original: On issuance of the final Order, before its dispatch by Post, the following message shall be sent:

"With reference to your SCN dt. XX.XX.2016, the final order has been passed on XX.XX.2016. The same shall reach you by Post shortly.

In case where additional information is required, information in this regard would also be sent by SMS.

This facility will be for all adjudication proceedings pending at Headquarters as well as divisional levels.

A pre-requisite for making this facility, a success is the availability of the mobile numbers of the asssessee/noticee. All assessee/Noticee of adjudication are requested to furnish the mobile number of the authorized person for 'SMS' under this facility. The furnishing of mobile number is purely optional and is for the benefit of the trade & industry so that they can avail of this facility. Alternatively, the same may be furnished in the adjudication sections. The required information may please be furnished in Annexure'A' enclosed.
