SUBJECT: Migration of existing Central Excise/Service Tax Assesseees to GST.

The Process of migration to GST has been going since 20.01.2017 in Central Excise (when all provisional ID's were made available to taxpayers via ACES website) and since 09.02.2017 in service Tax. This migration process is for CE/ST taxpayers who are not getting migrated through State VAT.

2. In order to assist the assesses for smooth transition to GST, this comissionerate has set up 04 GST Migration Seva Kendra in Vadodara-II Commisionerate , Central excise building, Aarkee garba ground, Subhanpura Vadodara and Halol division.

3. Simple steps for migration into GST are as under :

- Log on to www.aces.gov.in portal by using your existing ACES user ID and password.
- Obtain provisional ID and password either by clicking on hyperlink displayed in the pop-up intermediary opening page or by navigating through Home page<Menu<REG<Provisional ID for gST.
- Log on to www.gst.gov.in
- Create unique username and new password by using provisional ID and password received from ACES web site.
- Fill the enrolment application in Form 20.
- Please submit the Enrolment Form along with necessary documents.

Central Excise/Service Tax Registrants who have been provided Provisional ID by State Commercial Tax Department are NOT Required to again take fresh Provisional ID through CBEC.

4. DG, Systems, CBEC has launched an Android app "CBEC GST" (downloadable at Google Play store) to inform taxpayers about GST migration. Taxpayers could use 24 by 7 toll free helping at 1800-12-232 or send mail at cbecmitra.helpdesk@icegate.gov.in.

5.
